Religious tolerance, respect for learning, the concepts of chivalry and brotherhood - these principles were brought by the Islamic Moors when, in medieval Spain, they acted as "Beacons of Light" in the Dark Ages of European religious arrogance, intolerance and persecution. The Moors gave Europe an architectural and artistic heritage that is still a source of wonder to the modern world. It was in translation from Arabic, not the original Greek, that knowledge of Greek philosophy became prominent in Christian thought. Western mathematics are based on Arabic numerals and calculations, and the first effective medical school in Europe was founded by Jewish doctors who had been trained in Moorish Spain and North Africa. Tim Wallace-Murphy shows how over the last century it was

European Western powers who laid the foundations for the chaos that reigns in the Middle East. We need to find a just and equitable solution to these problems and we should begin by acknowledging our common spiritual heritage and the profound debt that Western civilization owes to Islamic culture

II. The Humanity of Muhammad by Dr. Craig Considine⁵,

What makes an American Catholic of Irish and Italian descent one of the leading global voices in admiration of Prophet Muhammad? In this overview of Muhammad's life and legacy, prominent scholar *Craig Considine* provides a sociological analysis of Muhammad's teachings and example. *Considine* shows how the Prophet embraced religious pluralism, envisioned a civic nation, stood for antiracism, advocated for seeking knowledge, initiated women's rights, and followed the Golden Rule. *Considine* sheds light on the

side of Prophet Muhammad that is often forgotten in mainstream depictions and media narratives. The Humanity of Muhammad is *Considine's* contribution to the growing body of literature on one of history's most important human beings.

III. Does God exist by Dr. Hans Kung⁶ Martin Douglas said in New York Times,

"A prolific writer and a prominent speaker, he promoted dialogue among religions and challenged Vatican doctrine on many fronts, provoking its censure." by this statement of a newspaper we can understand the thinking of the writer he put in this book, the question of God and religion is the main thing. He also addressed nihilism in it, then for many questions scientifically and rationally he answered that "God exists" and he proved that there are no meanings of morality, true freedom, equality and fraternity, humanity, liberality and social justice, just because we believe in God. This book is a great contribution on the question of title of the book. Being Christian he calculated all the minds exists in the society and answered them. He was being criticized as a Christian theologian.⁷

In the book "introduction to sociology: understanding and changing the social world" in its 15 th chapter, the author talked about religion and its need and also about its functions and defined religion in its conflict perspective and its symbolic interactionist perspective.⁸⁹ That is the main part of my article.

Muslim scholars preserved and enhanced the learning of ancient Greece, laid the foundations for modern science, medicine, astronomy and navigation and inspired some of our greatest cultural achievements. If it were not for the inherent tolerance for the People of the Book that was manifest within the Islamic world for over fifteen centuries, it is highly doubtful that the Jewish people could have survived as a racial and religious entity, and we would have lost their contribution to art, medicine, science, literature and music which is almost beyond measure. We in the West owe a debt to the Muslim world that can never be fully repaid. Despite our common religious and spiritual roots, we have thanked them with centuries of mistrust, the brutality of the Crusades and an imperial takeover that was conducted with callous indifference to the needs of the peoples we exploited" 10

3.2 Humanity:

There are many common things in all religions, first and foremost is humanity. Religious harmony can be created if the element of humanity should be highlighted and must be recognized globally in all religions. Everything in this immortal world is for humans because all humans are created on same pattern and same material. As Allah subhana says in holy Quran

Indeed, we created man from sounding clay molded from black mud" خَلَقَ الإنْسَانَ مِنْ صَلْصَالٍ كَالْفَخَّارِ وَخَلَقَ الْجَانَّ مِنْ مَّارِجٍ مِنْ ناَّرِ"

He created man of clay like the potter's, And the jinn did He create of smokeless fire."

3.3 Equal rights:

Then Allah sent a raven, scratching in the earth, so that he might show him, how he should hide the corpse of his brother. He said, 'Oh woe is me!
